The Jr's held a Buona Beef fundraiser over the superbowl weekend which brought in \$123.13. The Jr's will continue this fundraiser in the future. The Jr's plan to attend other classes to have their fundraising items available to purchase, as well at exhibition. The Nascar carwash fundraiser is almost ready to be rolled out, and benefactors can even have a digital gift card on their phone. March 19-the Jr's will host a babysitting day with an Easter theme. The Jr's will also be selling carnations at the special number competition.
