## SOKOL SPIRIT

Unit Meeting
March 6, 2019
President Bro. Maskill called the meeting to order at 7:33 p.m.
MINUTES: A motion was made by Bro. Bazata to approve the February meeting minutes. Second by Sis. Sanders. Motion passed.
CORRESPONDENCE: A letter was received from St. Barb's Food Pantry - thank you for our donations. We received a mailing from Sokol USA regarding Sokolfest in NY. Any interest in donations for sponsorships or placing an ad in the ad book?
PRESENTATION OF BILLS: Sis. Heetel turned in ad book money and $\$ 20$ from beer club. Sis. Heetel needs to be reimbursed for: Jan. Newsletter $\$ 13.20$ and stamps for $\$ 11.00$. Sis. L. Wilt submitted a bill for $\$ 158.38$ for the Falcon Key Club mailer. Bro. Wilt - for membership lunch. $\$ 596$ Rose's Catering, $\$ 294.08$ receipts for beverages, decorations, certificates, envelopes, postage. Sis. V. Wilt made a motion to pay the bills, second by Sis. L. Wilt. Motion passed.
BOI REPORT: Sis. Becker reported: Class Reports: Tots: 28 registered/ 23 average. Twenty five of the 28 will be participating in Exhibition. They are working on cal and special number before breaking to do the tumbling rotation. Girls' class: 21 registered/ 15 average. The class has finished learning the cal and special number and are now just perfecting them. Doing gymnastics in class and will soon start learning the routines for the May competition. GIJO class: 8 registered $/ 7$ average. Started learning the routines for the April competition. This class will participate in the gymnastics portion of the Exhibition. Boys' class: 6 registered/ 5 average. Doing cal and apparatus. Junior girls and boys: 3 boys and 2 girls are doing cal and special number. Working on fitness challenge. Senior Women: Average about 10 women. Learning the Senior II Cal and special number. There are about 4 women who will be doing the $\mathrm{Jr} / \mathrm{Sr}$ cal with the juniors for Exhibition and will be participating in the Jr. Special. The women are working on the Fitness. Senior Men: 16 registered. Men are working on cal and fitness challenge. Sr II Coeds: 19 enrolled/ average 10. The Senior Coed has finished the cal and are practicing. They are working on the Fitness challenge. Spin: There are four students in the Monday class and five students in the Saturday morning class. Sis. Barcal would like to get the bikes serviced do to the dust that was made during the remodeling. She will look into getting estimates for the tune-ups. Wheels: 15 enrolled/ 13 average. Exhibition: The theme is "Spirit of the Seasons." We received a grant from the Riverside Township of $\$ 1,500$ to be used toward the rental. The BOI made a motion to raise the price of tickets to $\$ 10$ with a $\$ 2$ off coupon to be used at the after party. $\$ 5$ for children $6-12$, and children 5 and under are free. Since then, we found out that publicity has gone out with last year's prices of $\$ 8$ for adults, $\$ 4$ for kids, and $\$ 7$ for members. This will happen next year. Sis. A. Maskill reported on the new spring floor. She found one that is 6 feet $\times 60$ feet which is assembled with wood and carpet. Cost is $\$ 3,648$ including shipping. Sis. L. Wilt suggested that maybe the Juniors would contribute toward the floor purchase. Rooms for the Sokolfest in Buffalo, New York at the Marriott are completely booked. Rooms may be available at the Doubletree. Class break after Exhibition will be March 24-31. The Senior II class will meet on March 26 for their monthly birthday luncheon.

Junior Board Report: Josie Mensik reported: Savings: $\$ 2,322.58$. Checking: $\$ 2,723.19$. The junior board will be selling candy at the Exhibition March 23. At the Beer Club, they made about $\$ 30$ selling popcorn. They may continue to sell popcorn at the Beer Club, but not every month. They also thought of selling water there. At the Special Number Competition on April 20, the juniors plan to again sell carnations for $\$ 1$ each. They will again have a basket raffle after Exhibition and will try to collect
donations for the baskets. The juniors did attend and help clean up after the membership brunch on February 24. The juniors are planning to attend and participate in USA Sokolfest in June. Discussion was held about rooming and chaperones. Bro. Bazata made a motion to approve the BOI and Junior Board report, second by Sis. V. Wilt. Motion passed.

TREASURER'S REPORT: Sis. Braun reported: Checking account balance as of 2/1/19 was $\$ 23,863.98$ and the ending balance as of $2 / 28 / 19$ was $\$ 20,200.57$. Safety Account balance is $\$ 30,821.67$ and the Memorial Account balance is $\$ 9,392.71$. Bro. Bazata motioned to approve the Treasurer's report. Sis. Barcal second the motion. Motion passed.
