Prior to Exhibition, the class finished the fitness challenge and most everyone participated. Men-The men started a spring volleyball tournament last week. There are four teams including the junior boys. Sr. Il Class-No report. Wheels-12 enrolled/11 average. Would like to encourage the BOI to purchase Wolfgang's used wheels for $\$ 3,800$. The Wheels class will perform at the dance recital here on June 8 \& 9 . Spin Class-Monday class has 4 that attend regularly and on Saturday, there are 5 attendees. Exhibition report: $\$ 4600$ profit. This includes ad book income. We could separate the line items for reporting.
