



Sokol Spirit Membership Meeting Minutes – March 1, 2023

Approval of February 2023 Minutes – Bro. Frank Tudisco motioned, Sis. Dorothy Becker second, approved

Correspondence: We received a thank you note from Brookfield Chamber of Commerce for hosting event at Spirit Thursday, January 12. We received a thank you letter from Holy Guardian Angels Parish for food pantry donations. A new book, *Czech Immigrants and Sokol Movement* by Robert Tomanek, and order form was passed around. Sis. Wendy Sanders brought in an old ad featuring a grocery store that used to be on Spirit property. Date of ad is unknown.

Building Management Director Report: Bro. Mark Shrofe (absent). Sis. Kathy Barcal presented the report. BMC has a "To Do List" that we are working on for the building.

A meeting has been scheduled to review roof repair proposals.

We have been getting non-member hall rental inquiries. For these rentals, beer is allowed but no bottles. Rentals will be \$1,200 + \$400 refundable deposit, plus security personnel. Junior Bulldog fundraiser rental will be this weekend.

Bench and pull-up bar were fixed.

The radiators are being monitored.

An energy audit will assist in identifying energy wasters around the hall. Utilities bills have been very high recently.
