# Building Management Director's Report: Provided by Bro. Adam Wilt

BMC is seeking members who live nearby the gym to be available to open and close gym doors for rentals. An email will be sent to Sokol members within 5 miles for help.

BOI to add classes to the calendar – Access granted to Sis. Lauren Wilt and Sis. Tricia Rini.

Need to select leads for the BMC including a Chair and leads for Rentals and the Calendar.

Reviewed sport court type flooring option with Jack from Eagle Youth Sports prior to our meeting. BMC would like an added cloth type of layer to be placed between the court and the wood floor. The BMC was notified that Jack is willing to comply with this request and store the floor cover offsite. Continued discussion about the future of offering rentals for hockey due to floor damage. Floor resurfacing costs approx. \$1,500. The full flooring project can cost \$15K-\$17K. If we plan to continue to offer hockey rentals, the floor needs to be covered/protected. The rental expense for Jack has been increased from \$300/day to \$400/day, and the contract will be revisited next year.

Plumbing: Flood Control is Buzzing – Call Preferred to have them look at it. Bro. Bob Barcal will call Jerry or Preferred Plumbing to look in the pit. Need to identify if the float or pump is bad. Bro. Mark Shrofe will call Preferred to investigate.

Lighting: Bro. Mark Shrofe will work to install new lights to shine on parking lot.
