1) Call to Order - Sign In Sheet Distributed around room 7:30

Spin bikes and that program will be discussed before the next BOI on March 24.

There have been no draws yet this year from PNC holding account where there is $\$ 10,024.98$.
There was $\$ 2100$ income to the memorial fund. We also hold dues money in the Memorial account to keep it out of sight, and that is $\$ 11,300$ of the total of $\$ 19,983.64$.
Sis. Becker moved, Sis. Lauren Wilt seconded to accept the report. Motion carried.
