## SOKOL SPIRIT MEMBERSHIP MEETING

## Held on Wednesday, May 7, 2014

The meeting was called to order by Sis. Wilt at 7:30 p.m. Bro. Wilt was excused from the meeting.
Minutes: A motion was made by Sis. Tooke to approve the minutes from the April 2,2104 meeting. Second was made by Bro. Shrofe. Motion passed. Minutes approved.

Barcal to place a $1 / 4$ page ad in the Landmark for $\$ 120$. Second by Sis. Tooke. Motion carried. A motion was made by Sis. Tooke to table the renewal of the DesPlaines Valley Council newsletter. Second by Sis. Barcal. Motion passed. A motion was made by Bro. Lebloch that Sokol Spirit contributes $\$ 250$ towards the Central District Men's Softball team. Second by Bro. Babka. Motion passed. We received a request from Bro. Mark Novak requesting that we make a donation to D103 Foundation Golf Outing. After some discussion, a motion was made by Bro. Bazata to give a wheel class certificate. Second by Sis. Barcal. Motion carried. A motion was made by Sis. Tooke to also give for Baby \& Me classes (4 sessions), second by Sis. Wilt. Motion carried. A motion was made by Bro. Maskill to give 1 month of free gymnastic classes, second by Sis. Barcal. Motion carried. Bro. Maskill will put the certificate together. The golf outing will be held on June $25^{\text {th }}$ at Carriage Greens, $\$ 100$ for golf and dinner and $\$ 50$ for the post golf $b$ ash. A letter was received from the BNC regarding the Memorial Day event on Monday, May $26^{\text {th }}$. A bus will be at Spirit at 7:30 a.m. for those interested in attending. Our juniors will be participating as well. A sign up will be passed around to volunteer to work at the Farmer's Market in Brookfield over the summer. The first one is on June $7^{\text {th }}$.

Educational Director Updates: Sis. Tooke reported that the Babysitting/Red Cross was held and there were seven students in attendance. The participants were fifth graders from St. John Lutheran School. Sis. and Bro. Tooke paid for the $8^{\text {th }}$ student. These participants were also given information about Sokol Spirit, especially our wheels program. They were also given the book, CD and certificate. Junior Board Report: The juniors' savings account had $\$ 1,970.99$ and the checking account had $\$ 1,317.32$. No bills or correspondence were presented. The juniors sold carnations at the Special Number Competition. They will babysit on May 3 during the adult quiz night. The extra candy they had left over from exhibition will be sold at the girls and boys competitions May 10 and May 17. Parents are taking pictures to use in the junior scrapbook. The juniors plan to reimburse each instructor $\$ 10$ for supplies they used during exhibition. Possible dates are being
discussed for the fly-up and a summer Great America trip. May 20 will be the pot luck. A question was raised as to a Jr. sleepover for the Bohemian National Cemetery parade/ceremony on May 26, 2014. Information about the event has not yet been received. Next meeting will be May 15, 2014.

Practicing stunts for the pet parade and the $4^{\text {th }}$ of July parade. Jr. Girls 7 enrolled/4-5 average. Won 2nd place at the Special Number Competition. The juniors are doing a lot of fund-raising. They hope to help pay for a mini-tramp. Women working on cal and exercises. Sr. II CoEd using the cal as stretching exercises and playing games. $\quad$ st Class Boys 6 enrolled/5 average. Using a new format with $1^{\text {st }}$ and $2^{\text {nd }}$ class boys of learning skills related to their favorite sports. They use two apparatus a night to train for competitions. Jr. Boys 4 enrolled. Two second-class boys are moving up into juniors. Men average about $6-8$ a night. Hosted a district floor hockey night. Sis. Babka made a motion to pay the $\$ 325$ to Sis. Barcal. Second by Bro. Bazata. Motion passed. We will need marketing for the spin and soccer programs.
B.M.C.: Bro. Shrofe reported that the gutters have been cleaned; south side cleaned. We will need a recommendation at the annual meeting for the purchase of new tables. BMC is looking into purchasing a new sandwich board. A new one costs about $\$ 850$. We will try to get Matt Sanders to fix the gym floor and hang the baby
changing tables. We have a new copier/printer. It currently only makes copies because we need a line from the computer and printer. Once a line is established, training will be held in the summer. We currently have six rentals over the summer thru 10/11/14. The Chicago Public School teachers/coaches would like to do volleyball at Spirit. They need forms from us.
