<u>ADA compliance report:</u> Currently the ADA committee is looking into quotes/evaluations from companies to install an elevator in the building; what other sort of structure changes we need; and a potential timeline for the completion of this project. Currently the estimated cost of the elevator would be between 95k-110k, with an estimated time line of 4 months to complete. The committee will look for a few more quotes. <u>BMC</u>: The trees have been cut down. Continuing to plan the exhibition celebration party. This year the DJ will set up in the lower hall and the BMC is still looking at activities for children to do in the gym (i.e. a bounce house).

<u>PR/Marketing Director:</u> Sis. J. Keefe is resigning from the position. Pres. V. Wilt asked for volunteers to take this position on, perhaps in a committee form. She mentioned that there have been members assisting with PR along the way already this year.

Exhibition ad book: there is still time to submit well wishes and donations. Sis. B. Bossany suggested to use the exhibition email address to send things instantly. Keep an eye out in your mail for the next newsletter.

<u>Junior Board:</u> The last meeting was held on 2/19. Finances: checking=\$3187.35, savings=\$2318.37. The juniors made \$191 at their class bake sales. They kept track of the most popular items and will bring those back for the next sale. Upcoming fundraisers: carnations at Special # competition, World's Finest Chocolate, Candy sale at exhibition (reduced budget to have less leftover), basket raffle after exhibition, party-lite candles (in time for Mother's Day delivery). They are considering selling Krispy Kreme donuts as well. There will be an incentive contest to see which Jr. sells the most candles. The Jr's will be hosting a babysitting night during the next Team Trivia night in April. Their next meeting is scheduled for 3/19.

<u>BOI</u>: The focus is on exhibition right now. SPIN class is expanding! There will be a Thursday evening class added. It was decided that the Baby & Me 2 class instructor will be paid \$60/month. Recent BOI expenses include: paying for the DJ at the program-\$200. The heads or tails fundraiser will make a return to the program this year.

<u>Presentation of Bills:</u> \$337.29 for the new sound system; Ad book mailing-~\$50. These items were previously approved. As a sidenote: the new SPIN bikes were paid for from the Memorial Account.
